In Res. Multiple Candidates

ESB Resolution: 2017-004

Election Supervisory Board Chair Catrin Watts delivered the majority opinion of the board:

"In the matter of multiple candidates on multiple counts of failure to submit timely and/or accurate

financial disclosures."

Whereas, Section 7.17 of the Campus-wide Election Code reads, "FINANCIAL DISCLOSURE

STATEMENT. Financial disclosure statements shall be filed with the Election Supervisory Board,

in the Student Government Office (SAC 2.102) or other locations designated by the Election

Supervisory Board, at the following times: (a) By 4:30pm CST, on the first day of campaigning; and,

(b) By 4:30pm CST, on the last day of the second week of campaigning; and, (c) By 4:30pm CST, on

the last day before the general or special election; and, (d) By 4:30pm CST, on the first day

ofcampaigning in a runoffelection; and, (e) By 4:30pm CST, on the last day of voting in a runoff

elections," and,

Whereas, Failure to submit timely financial disclosures is punishable by the ESB sua sponte as

outlined in Madison Gardner/Antonio Guevara v. the Election Supervisory Board (Docket

Number: 2012SE-005); and,

Whereas, The Election Supervisory Board voted in ESB Resolution 2016-012 to assess a Class C

Violation resulting in a forty-eight (48) hour moratorium on campaigning and a reduction in

candidates' spending limits which would result in the candidates' total expenditures being one

hundred and nineteen percent (119%) of the candidate's spending limit for candidates who failed to

report a fine on their third financial disclosure; and,

Whereas, The Election Supervisory Board voted in ESB Resolution 2016-012 to assess a Class D Violation resulting in immediate disqualification for candidates who failed to submit the third financial disclosure in a timely fashion; and therefore, be it,

Resolved, That the following candidates are hereby issued the aforementioned Class C Violation:

Resolved, That the following candidates are hereby issued a Class D Violation resulting in disqualification:

Blake Burley and Robert Guerra - Student Government Executive Alliance,

Suchin Kundra - Business Representative Candidate,

Emily Mackay - Communication Representative Candidate,

Abby Shosid - Communication Representative Candidate,

Jake Beach - Law Representative Candidate,

Jay Anand – Liberal Arts Representative Candidate,

Daniela Cos – Liberal Arts Representative Candidate,

Nithin Kakulavaram – Natural Sciences Representative Candidate,

Wendy Lopez - University Co-op Board of Directors 2017-19; and therefore, be it further,

Resolved, That any adversely-affected party has the right to appeal this decision pursuant to Section 5.1 of the Campus-wide Election Code, which reads, "APPEAL OF ESB DECISION: Any party adversely affected by a decision of the Election Supervisory Board may file an appeal with the entity with appellate jurisdiction within twenty- four (24) hours after the adverse decision is announced, unless the Election Supervisory Board's decision takes place during a voting period."

In conclusion, the Election Supervisory Board submits its resolution on Thursday, March 2, 2017 with the majority of board members who were present at the meeting.
